Motor Vehicle Appeal Procedures

If you disagree with the fair market value of your motor vehicle, you may appeal the value to the Board of Assessors. For the appeal process to begin, your appeal needs to be in writing (using the PT311A-MV Appeal Form) and must be received by the Board of Assessors no later than 45 days from the date the vehicle is purchased. State regulations require that all ad valorem taxes be paid prior to filing any appeal with the Gordon County Board of Assessors.

How To Appeal:

- Please use the state's [PT311A-MV appeal form](#) to start the process. (Ensure all required information including correct contact information has been completed)
- Submit copies of the registration documents and photos of the vehicle, along with the completed appeal form. Photos must include all four sides of the vehicle, inside, damage (if any), odometer reading, and VIN number.
- If this vehicle was recently purchased, please include the purchase price on the appeal form as well as a copy of the bill of sale.
- Mail/email the completed appeal form with photos and all documentation to:
